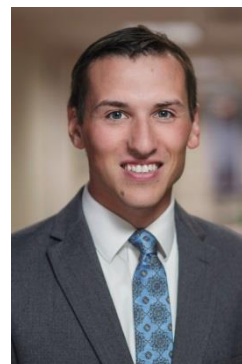


Attorney Anthony C. Famiglietti Joins Neubert, Pepe & Monteith, P.C.
